- Approval of previous meetings minutes
 - Approved unanimously
- Greg Eckhardt – discussion of hiring an animal control officer for the town
 - Greg poses the hiring of an animal control officer to handle things like dog bites, beaver issues, lost dogs, loose dogs, stray cats etc. He notes dog bites and poultry attacks by off leash dogs. He notes an approximate \$250-\$300 monthly charge as a cost estimate for using a shared resource.
 - Town Clerk notes two dog bites in the last year. She recommends a part time shared resource from neighboring towns. Presented the VT State procedures for animal control issues for review.
 - SB requests time to conduct diligence and read the VT Procedures and will discuss next meeting, along with the Town's dog ordinance.
 - Town Clerk stated K Everts stated a concern about the beaver issue and suggests a humane control device. Suggests SB call 802.253.1592 or email www.protetourwildlife.org.
- Discuss Homestead Declaration Penalty
 - SB states the HDP is there for a solid reason and should be left in place. In addition, they feel that favor should not be given anyone by reversing a penalty.
- Treasurers Report

 - Approved to continue to use Jay Merrill, based on pricing and mud season availability, if needed

 - We have the wetland permit application. Before we can submit all the abutting landowners need to be notified by mail. Will is sending out the notifications so we can submit the permit application.
